

The Peter Siddle Classic Charter





1) Purpose

- a) The Peter Siddle Classic (the “PSC”) is a golf based member organisation focused on the promotion and continuing success of the annual Peter Siddle Classic.

2) Specific Objectives

- a) Ensuring the successful planning and staging of each PSC.
- b) Endorsing new PSC locations in accordance with member approvals.
- c) Ensuring changes to PSC members or membership categories are endorsed by members.
- d) Ensuring that PSC reflects an ongoing commitment to treat all PSC members fairly.

3) Membership

- a) Membership is currently limited to 3 categories;

- b) Additional Membership categories maybe created with a majority vote of all founding members.
- c) New members
 - i) All new members will hold Probationary Membership for a minimum of one PSC event;
 - (1) Applications for probationary membership must be proposed by a founding or full member and seconded by a founding or full member, with at least one being a founding member.
 - (2) New members will be assessed on their suitability to the current members and a strict 'No Dickhead' policy will be enforced.
 - (3) Probationary membership will be granted with a majority vote of founding and full members.
 - (4) Probationary members may move to full membership with a majority vote of Founding members and Full members

4) Meetings

- a) Meetings will be held on an as required basis and will be arranged via the "PSC" whatsapp chat.
- b) Meetings may be proposed by any founding or full member.

5) Sub-Committees

- a) Handicap Committee ("HC");
 - i) The HC will contain a minimum of 3 full or founding PSC members and will meet at least 14 days prior to any PSC.
 - ii) The HC will decide the handicap of any PSC members who do not have a current Golf Australia ("GA") recognised handicap.
 - iii) HC will have responsibility in ensure the correct policies are in place prior to each PSC to enable the movement of member's handicaps during PSC based on performance and scoring.
- b) Match Committee ("MC");
 - i) The MC will contain a minimum of 3 full or founding PSC members and will meet at least 14 days prior to any PSC.
 - ii) The MC will have ultimate responsibility for deciding match format of each PSC after consultation with all PSC members;
- c) PSC Organising Committee ("PSCOC") ;
 - i) The PSCOC will contain a minimum of 2 full or founding PSC members and will meet at least 9 months prior to any PSC event.
 - ii) The PSCOC will prepare and collate any PSC location submissions and prepare a vote of members.
 - iii) The committee will work closely with the finance committee around any funding requirements as needed.
 - iv) The PSCOC will recommend travel times and prepare options for hotel and course transfers.
 - v) Where appropriate the PSCOC will arrange
 - vi) Once planning is finalised the PSCOC will provide an approximate costings to each PSC member.

- d) Finance Committee ("FC");
 - i) The FC will contain a minimum of 3 founding or full PSC members when required.
- e) Additional Sub-Committees may be created with relevant approval from obtained from a members meeting.
